Typescript copy of lease: Jane Smart, spinster, Corderry, one of the daughters and co-heirs of Alexander Smart, farmer, formerly of Lisrenny, grants to John Taaffe, gentleman, Ardee her undivided third part in a dwelling house, garden and backyard in Castle St, Ardee with a piece of bog in the Great Bog usually held with the same house from 1 November 1783 for 99 years, at the annual rent of £2-10-0. Smart signs by mark. Includes terms of payment.

Typescript copy of lease: Mary Hargrove, widow, Lisrenny, grants to Elizabeth Flanagan, widow, Ardee, her undivided one third part of a premises in Castle St, Ardee (see PP00038/001) now in possession and occupation of Elizabeth Flanagan and formerly in possession of John Taaffe, deceased from 1 May 1830 for 52 years, at an annual rent of £35.
