Admin/Biographical History:	<p>The workmen's accounts book relates to the estate owned by Lord Clermont (1815-1887) and span from July 1864 until October 1866 in the Heynestown (Haynestown, Hainstown) area of Dundalk.</p> <p>The origins of the estate began in the 17th century under an army officer Sir Faithful Fortescue (c. 1581-1666). The property was then owned by successive members of the Fortescue family. Originally called Thomas Fortescue (1815-1887), Lord Clermont rose to the Irish peerage in the year 1852 and gained the title Lord Clermont. Lord Clermont gained the amalgamation of both the Clermont estate and Dromiskin estate in 1854. He was recorded as a great landlord in comparison to his predecessors through his work on relief committees during the Irish famine. He later became a peer of the United Kingdom in 1866 and was given the title Baron Clermont. This gave him the right to sit at the House of Lords. Lord Clermont died childless in 1887. The land was later passed to Chichester Fortescue, 1st Baron of Carlingford (1823 – 1898) until his death at which point a share of the estates were passed to Viscount de Vesci. Descriptive List

Workmen's Accounts, Heynestown, 1864-1866, 1 item

The accounts feature two workers, John Hodgers and Thomas Hodgers. The days worked, the total number of days worked, wages per day in shilling and halfpenny, the total value of the weeks work in pounds, shilling and halfpenny, cash paid onto the account that week and any observations made about the workers. Each page also includes information in a header including the name of the writer of the accounts and the recipient. The observations note that work took place in both Dundalk and Heynestown.
