Admin/Biographical History: The Dundalk Regatta committee in 1890 included: M Hagarty JP CTC, OJ Kelly CPLG, William Tempest HC, James Murphy JP HC, Henry O'Connell HC TC, T Williamson HC, F McGinity, J McAdorey, JC Sellars MD, P Cahill CE, TC Macardle, Thomas Brown HC, WM Patteson JP, P Mathews (*Examiner*), RL Brown JP, VS Carroll HC, PV Carolan HC, HM Williamson and John Connick HC. Thomas Murphy was the Chairman in 1890, Charles A Duffy was honorary treasurer of the Regatta Fund and William Twibill, PR Finigan and JP Dempsey were honorary secretaries. Meetings took place in the cloakroom of the Town Hall.

A regatta is an event whereby teams compete against one another in a series of boating races such as rowing, sailing, canoeing, etc. Regattas were extremely popular from the latter part of the nineteenth century to the mid-twentieth century and played a large part in the annual festivities of many Irish towns. It was a time when competing teams and visitors arrived from neighbouring towns to take part. A regatta and aquatic sports was held at Dundalk on 7th August 1890, while previous regattas included Greenore in 1872, Omeath in 1874, Dundalk in 1876, [1879] and on 4th August 1885, the Boyne regatta in Drogheda on 7th July 1885 and possibly others. The Dundalk Regatta saw the town represented by Dundalk Rowing Club which was also known locally as Dundalk Boating Club. As in many sports,

competition is greatest between neighbouring towns, with the greatest rivalry shared between Dundalk, Drogheda and Newry.

Event programme from Dundalk Regatta and Aquatic Sports Day dated 1885. The programme includes sailing, rowing and swimming races along-with a programme of music which includes a fireworks display. The president is Colonel Russell, 1st Royal Dragoons; the treasurer is HL Webb, esquire, 1st Royal Dragoons and the honorary secretary is William Twibill esquire. The committee includes Lieutenant Robertson, 1st Royal Dragoons, S Kelly, HF McCann, J McCann, P Moore, W Lyndon, JB Watson, T Callan Macardle, F McGinity, P Donovan, P Hayes, A Watters, RL Brown JP, VS Carroll, J Murphy junior, PB Troy, PV Carolan, JF Farrell, T Connick, J Connick, CP Cooper, E Carlton, J McAdorey and CA Duffy.

Event programme from the Boyne Regatta (Drogheda) held in 1890. This programme was sent by A O'Neill, Newry Rowing Club as part of correspondence dated 25th July 1890 (see PP00297A/006/003). The programme features a number of championship and challenge races along-with the name of the Boyne Regatta committee: TH Simcocks, JJ McCann, J Bellew Kelly, P Ternan junior, GB Bowers, W Moore, R McIntosh, J Daly and G Galbraith. The honorary secretary is JV Byrne and the honorary treasurer is Henry J Daly.

The programme includes family and single ticket prices, all race events and a programme of music for the day to be performed by the Dundalk Emmet Band. Notebook used to record the minutes of the Dundalk Regatta and Aquatic Sports committee meetings. Inserted into the notebook are two handwritten requests to attend meetings of the managing committee. The committee meetings are few (minutes for four are recorded) and concentrate on the setting up of the committees, requests for subscriptions to the regatta fund, and the programme of events, with a draft programme including prizes written in the notebook. It notes that the Dundalk Emmet Band would be in attendance at the Regatta.

Thomas Murphy was the Chairman in 1890, Charles A Duffy was honorary treasurer of the Regatta Fund and William Twibill, PR Finigan and JP Dempsey were honorary secretaries. The Regatta Fund committee included M Hagarty JP, WM Patteson JP, J McCann, James Murphy JP HC, AA Watters, M Walsh, C Kelly, TC Macardle, James Johnston TC, VS Carroll HC, Thomas Brown HC, T Connick, PV Carolan HC, Henry O'Connell HC TC, T Williamson HC, T Roe, HM Williamson, JC Sellars MD, P Mathews (*Examiner*), P Cahill CE, J Gaskin CE, John Connick HC, Captain James Rice and T Murphy.

The Managing Committee formed in July 1890 consisted of the committee members of the Dundalk Boat Club: PR Finigan, WB Connolly, JP Dempsey, PV Carolan, J Murphy, JH Chandler, JJ Meagher, JR B Watson, HM Williamson, J Campbell, JJ Caraher, Patrick Carolan and E Goodman and also OJ Kelly CPLG, F McGinity, P Cahill CER, P Mathews, W Twibill, CA Duffy and Thomas Murphy, Blackrock.

Letter from William Tempest to the committee explaining his absence from the upcoming committee meeting due to be held the following day and noting that he will still help in any way that he can. He pledges to subscribe £1 towards the prize fund.

Undated letter from [OJ] Kelly, Blackrock, to the committee asking for his name to be withdrawn from said committee as he is no longer in a position to attend meetings. The date is probably mid-July 1890.

Two letters from A O'Neill, honorary secretary of Newry Rowing Club to the regatta honorary secretary JP Dempsey. One letter explains that Newry RC will still take part in the regatta on 7th August although they have not been in training; provides apologies for not being able to supply a programme from Newry Regatta but encloses the Drogheda (Boyne) Regatta programme for that year (see PP00297A/001/002). (2pp)

The second letter explains that Newry RC will be sending their boat by rail or by wagon via Dundalk road on the morning of the regatta. It also supplies the names and weights of the Newry team which includes F Fisher (bow), J Gill (no2), J Fisher (no3), George Sloan (stk) (stroke) and J Carty (cox). It notes that the team colours are black and gold. (2pp)
